Good Morning Andrew,

I wanted to update you and receive your approval to move forward with the Council Chamber procurement process.

Results of the Pre-Qualification Process – we were fortunate to have received seven contractor submissions as part of the pre-qualification process. Of the seven submitted, we are recommending that five be pre-qualified and advance to the RFT stage of the procurement process. Within the RFPQ we identified that a maximum of six contractors would be selected by the Evaluation Team. The overall evaluation scoring for submissions has been retained here and a very brief summary is provided below. With your approval, we will move forward with providing the attached DRAFT EMAIL (Results Notice) to the successful five firms and the attached DRAFT EMAIL (Unsuccessful) to the other two firms. These firms were unsuccessful for the following reasons:

ONIT Construction Inc. - Most reference projects were a significant distance away and were smaller in scale and scope compared to the Council Chamber Upgrade project. Of the scored reference projects, there were some reference submission back to the City that were not positive. Tied for lowest scored submission overall.

Mega Group Construction Limited - Most reference projects were a significant distance away. Of the scored reference projects, there were some reference submissions back to the City that were not positive. Tied for lowest scored submission overall.
